Added CONT3.0-X certification and changed validation rules to allow submissions for CONT3.0-X funds



- **Employee can get stuck in the opt out period** - For various scenarios where there are no held contributions at the end of the opt out period, the member is left in the opt out period with no held amounts and no member file release date set despite opt out period end date being set
- **Only calculate held amounts when employee/employer amounts are correct** - Upload a file with a new employee but invalid employee and/or employer amounts. The held amounts are incorrectly calculated - this causes problems later on.
