Description	Multi employer files can now be upload and submitted for STPv2. The declaration and signing statement is dynamic based on the multi employer scenario.		
Reason	This allows employers to upload multi-employer STPv2 files

Assumptions	 Existing single employer file upload remains the same. Multi employer submission is not supported via the API Users will not be able to select the 'Confirm and Send' button if the multi employer file has previously been submitted. Only the first employer is looked at to determine RAMSSP, EMSSP First employer with intermediary data ==> RAMSSP message First employer with no intermediary data ==> RAMSSP message When there are multiple employer payments in a batch, the status is the last status received (unless that status is ATO Success). The status w only go to ATO Success when all employer submissions are successful. A submitted file cannot be deleted. The last modified date reflects the latest message received. Note that the status might not always change in this case. Messages may be received out of order For emails, for multi file Portal uploads - the trigger is on each ATO Error or Partial Success or Warning response. In other words, emails are n grouped by multi employer file submissions. ATO Message level responses are displayed in an error box on the historic contributions page

Description	ion If a user clicks off member maintenance then the existing file is stripped of any members that haven't been changed. If this results in all me from the file being removed then the file is automatically deleted.		
	This means that the historic contributions screen now only shows the file containing any members that have been changed.		
	When the user clicks off the member maintenance change and doesn't make any changes then automatically delete the file. The file is not viewable in history.		
Reason	This is to avoid a build up of member maintenance files and provide clarity over what has been changed

Assumptions	 Applied to both member maintenance and add member. 3 Validation And Rule Changes

The ATO have released a new STPv2 package (version 1.5) with some additional validations.

Employer DDA	A new validation has been added on employer DDA. This validation will raise an error on the member during file upload if their employer has a payment method of direct debit and has contributions enabled but has not approved the employer direct debit authorisation. The employer will have to go into employer maintenance and check the DDA to remove the error.	This validation is on the GRID_RULES.JUEL tab, and therefore fires during member file submission. Employer.ContributionsEnabled must be set to true, Payee.PaymentMethodCode set to 'DIRECTDEBIT' and Employer.DDA must be set to false for an error to be raised.	MIG.J.Emp.0002

On the validations page, validation errors will appear as the contribution amounts will show the formula instead of the computed contribution amount in the excel file
